2. More Emphasis should be given on payments via cheques instead of cash payments.
3. Instance were found where Proper bills (i.e Pucca Bill) were not available for some expenses.
4. Sweep Facility should be availed in bank account so as to earn more Interest.
5. GST & TDS on Purchase of Materials & Payments to contractors are not deducted.
